Purpose

1. This briefing provides an update on progress implementing the Crown Response Plan following the Royal Commission of Inquiry into Historical Abuse in State Care and in the Care of Faith-based Institutions.

Recommendations

- 2. It is recommended that you:
 - a) note the Annual Report on the Crown's response to the Royal Commission into Historical Abuse in State Care and in the Care of Faithbased Institutions, covering the period from June 2024 to 30 June 2025;
 - b) **note** that the Annual Report provides a high-level overview of implementation progress across key areas, including redress, survivor engagement, system reform, and workforce development;
 - note that this is the first formal progress report, building on the baseline commitments outlined in the Crown Response Plan published in May 2025;
 - d) **note** that this first Annual Report will be accompanied by a Cabinet paper to support transparency and public accountability, in line with previous Cabinet decisions (ECO-25-MIN-0060 refers); and
 - e) **note** that future Annual Reports will be tabled in the House of Representatives in accordance with parliamentary practice, and will not require Cabinet consideration.

Background

- 3. The Royal Commission released its final report in June 2024, titled *Whanaketia Through* pain and trauma, from darkness to light Whakairihia ki te tihi o Maungārongo.
- 4. The Annual Report 2024–25 is the first formal report on progress and achievements under the Crown Response Plan. It contains highlights across the three objectives in the Crown Response Plan. The report reflects the Crown's commitment to a coordinated, transparent, and survivor-informed response to the Royal Commission's recommendations.
- 5. This update is being provided in line with previous Cabinet decisions (ECO-25-MIN-0060 refers).

Highlights from the Annual Report

6. The Annual Report outlines progress across the three strategic objectives of the Crown Response Plan. These include:

Objective One: Address the wrongs of the past – including redress and acknowledgement of survivor experiences

- 7. Following Budget 2025, the Crown increased average settlement payments for new claims and introduced a top-up process for previously closed claims, resulting in \$3 million paid to 248 survivors by 1 July. Alongside these immediate improvements, the Crown Response Office is leading a broader redress reform programme focused on building a consistent, accessible, and survivor-centred system.
- 8. A \$2 million fund was also launched to support NGOs and community groups, with 22 organisations and one local authority receiving funding by June 2025.

Objective Two: Make the current care system safe – through leadership, oversight, and safety-focused reforms

- 9. The Social Workers Registration Board released *Toitu te ara Tauwhiro 2025–2028*, the first cross-system workforce strategy, with Oranga Tamariki committed to its implementation. Budget 2025 allocated over \$112 million to support workforce safety and professionalisation, including in secure residences.
- 10. Agencies have advanced reforms such as digitised safety checks, physical restraint training, and a volunteer policy under review. The judiciary is implementing trauma-informed training, and Te Ao Mārama is being embedded to improve fairness for Māori and survivors. Oranga Tamariki continues to embed care standards, while Health New Zealand is planning safety upgrades in mental health units.

Objective Three: Empower those in care, their families, whānau and communities — by improving access to records, preventing entry into care, and listening to lived experiences.

- 11. Progress has been made to strengthen survivor and community voice across the system. Oranga Tamariki has established new advisory groups for youth, rainbow, disability, and Pacific peoples, with permanent appointments underway.
- 12. The Ministry of Social Development is improving complaints and incident management infrastructure, supported by targeted funding.

- 13. The Crown Response Office continues to promote transparency through regular pānui newsletters and has established a Ministerial Advisory Group to embed survivor perspectives in decision-making.
- 14. Whaikaha launched the *Whaimana | Support My Decisions* website to promote autonomy, which saw strong uptake with over 2,800 visits in its first month.
