Crown Response Annual Report 2024 - 2025

Proposal

This paper provides the inaugural Crown Response's Annual Report 2024-2025 in response to the Royal Commission of Inquiry into Historical Abuse in State Care and in the Care of Faith-based Institutions.

Relation to government priorities

This paper progresses the Government's response to the Royal Commission of Inquiry into Historical Abuse in State Care and in the Care of Faith-based Institutions (the Royal Commission).

Executive Summary

- In May 2025 Cabinet invited me to report back by 30 October 2025 with the first annual monitoring report on the Crown's Response to the Royal Commission (ECO-25-MIN-0060 refers).
- The inaugural Crown Response Annual Report from July 2024 to 30 June 2025 provides a high-level overview of progress made since the Royal Commission delivered its final report and is a baseline for future updates as the Crown's response continues.

Annual Monitoring Report

- During its tenure the Royal Commission of Inquiry into Historical Abuse in State Care released two comprehensive reports *He Purapura Ora, he Māra Tipu* (2021) and *Whanaketia Through Pain and Trauma, From Darkness to Light* (2024).
- These reports provided a comprehensive account of survivor experiences of abuse and neglect in care. They revealed decades of systemic abuse and neglect of children, young people and adults in State and faith-based care, exposing deep institutional failures. The Royal Commission provided significant recommendations on systemic changes to prevent such harm from recurring.
- In Budget 2025, the Government committed \$774 million to improve the redress system and strengthening the care system. This investment supports a whole-of-government approach and is coordinated by the Crown Response Office across eight agencies. The Government also established the Crown Response Office in September 2024, led by a functional Chief Executive and reporting to the Lead Coordination Minister.

- Budget 2025 funding will enable improvements in safeguarding, workforce capability, mental health and addiction services, and targeted social investment initiatives to prevent entry into care. It also supports enhancements to complaints systems to ensure timely and effective responses.
- The Crown Response Office's Annual Report 2024-2025 is attached (Appendix One). It provides an update on progress implementing the Crown Response Plan and builds off the baseline report dated May 2025 (Appendix Two). It was developed through agencies self-reporting against the Royal Commission's recommendations.
- 10 The key activities covered in the annual report include:
 - 10.1 the public apology on 12 November 2024 for abuse and neglect in care;
 - 10.2 a range of initiatives in relation to survivors of torture at the Lake Alice Psychiatric Hospital Child and Adolescent Unit, including the reimbursement of legal fees for round one claimants and the establishment of torture specific redress;
 - 10.3 the establishment of a Child Protection Investigation Unit to identify systemic failures and improve safety within Oranga Tamariki;
 - 10.4 the establishment of a survivor support fund for organisations supporting survivors of abuse in care as well as for local authorities to undertake work connected with unmarked graves;
 - 10.5 funding in Budget 2025 to improve the redress system for abuse in state care, including increasing average payments and top up payments for survivors with previously settled claims; and
 - 10.6 investment in Budget 2025 in multi-year initiatives to prevent, identify, and respond to abuse and neglect in care, including \$70.9 million in time-limited contingency funding to support workforce safety and capability, alongside \$41.251 million for professionalising the workforce in Oranga Tamariki residences.
- Related initiatives from the Ministry for Social Development, Oranga Tamariki, Health New Zealand, the judiciary, Social Workers Registration Board, Archives New Zealand, Citizens Advice Bureau, Survivor Experiences Service and others are also included.

Financial Implications

Budget 2025 set aside \$70.9 million over four years in tagged contingency funding for the Making the Care System safe – Building a Diverse, Capable and Safe Care Workforce initiative. Care agencies are working together to scope and design workforce safety and capability measures. Initiatives are subject to significant Budget 2025 spending decisions. This includes

Legislative Implications

Population Implications

Several population groups are over-represented, as both survivors of abuse in care and in the current care system. The Annual Report outlines the progress made in responding to the Royal Commission's recommendations for all survivors, including the population groups identified in the Royal Commission's report.
