Government response to the Petition of Scott Savage

Proposal

This paper seeks approval of the Government's response to the Petition of Scott Savage: Abuse in Care survivor pay-outs to be \$3.5m per survivor (the Petition).

Background

- The Petitions Committee received the Petition, which calls for survivors of abuse and neglect in state care to receive the sum of \$3.5m in redress.
- On 3 April 2025, the Petitions Committee referred the Petition to the Government for a response.

Comment on the Petition

- The Petition asks that the House of Representatives urge the Government to pay each survivor, and the families of each survivor who is no longer living, \$3.5m each for the abuse experienced while in the care of the State. It received eight signatures of support.
- The Petitions Committee referred the Petition to the Lead Coordination Minister for the Government's Response to the Royal Commission's Report into Historical Abuse in State Care and in the Care of Faith-based Institutions (the Lead Minister) in accordance with Standing Order 380.
- The Government responds to the Petition in the context of Government decisions for redress for survivors of historical abuse and neglect in care which were announced on 9 May 2025.

Timing of the Government response

The Government response must be presented to the House by Friday 4 July 2025.

Consultation

This paper and the response to the Petition were consulted with agencies involved in the redress system for abuse and neglect in care. They are the Ministries of Health, Education and Social Development, the Department of Corrections, Te Puni Kökiri and Oranga Tamariki. The Department of Prime Minister and Cabinet and the Treasury were informed.

Government response to the Petition of Scott Savage: Abuse in Care survivor pay-outs to be \$3.5m

Introduction

- The Government has received and considered the Petition of Scott Savage (the Petition), which was referred to the Government for a response on 3 April 2025. The Petition asks that the House of Representatives urge the Government to pay each survivor, and the families of each survivor who is no longer living, \$3.5m each for the abuse experienced while in the care of the State.
- The Government responds to the Petition in accordance with Standing Order 380, and in the context of decisions for redress for survivors of abuse and neglect in State care announced on 9 May 2025. Information about the announcements can be found on the Crown Response Office website.

Government response

- The Royal Commission into Historical Abuse in State Care and in the Care of Faith-based Institutions (the Royal Commission) detailed the widespread and sometimes extreme abuse and neglect of children, young people, and adults, across a wide range of care settings. These included disability, mental health, social services and educational settings, and community and faith-based care.
- The Royal Commission's reports, information from its hearings, interviews with survivors and others, and documentary evidence, provide the basis for the recommendations that are set out in its:
 - 4.1 2021 redress report He Purapura Ora, He Māra Tipu from Redress to Puretumu Torowhānui (He Purapura Ora)
 - 4.2 2024 final report Whanaketia Through pain and trauma, from darkness to light Whakairihia ki te tihi o Maungārongo (Whanaketia).
- In response to the Royal Commission, the Prime Minister and seven public sector agency leaders formally apologised to survivors of abuse and neglect in care on 12 November 2024. In his apology, the Prime Minister acknowledged specifically that torture occurred at Lake Alice Psychiatric Hospital Child and Adolescent Unit. The apologies made can be found online on the Crown Response Office website.
 - The Prime Minister also announced an investment of \$32 million to increase capacity in current redress and claims systems from approximately 1350 to 1550 claims per year. He also announced a \$2 million dual purpose survivor-focussed fund for local authorities, non-governmental organisations and community groups and an annual day of reflection on the one-year anniversary of the public apology,12 November 2025.
- In December 2025, we announced details of a new redress scheme for Lake Alice torture survivors. It includes a financial payment, a new written apology which explicitly acknowledges torture and support to access to support and

rehabilitative services. Eligible Lake Alice survivors can choose an expedited payment of \$150,000 or choose an individual payment pathway. Through the independent pathway, their claim will be independently assessed by an independent arbiter who will determine final payment amounts within an envelope established by Ministers.

- On 9 May 2025, as Lead Coordination Minister for the Government's Response to the Royal Commission's Report into Historical Abuse in State Care and in the Care of Faith-based Institutions, I announced details of Government decisions relating to redress for survivors of abuse and neglect in state care and a \$533 million redress package.
- 9 The State redress system will continue to provide a safe, supportive environment for survivors to share their experiences; facilitate acknowledgements and apologies for abuse in care; facilitate access to care records, support services, legal supports and acknowledgement payments. It will enable redress agencies to share insights on systemic issues relevant to abuse in care and the harms experienced.
- 10 In addition, the Government has decided to:
 - increase the average redress payment for survivors of abuse in State care (from \$19,180 to \$30,000);
 - enable survivors with previously settled claims to access a fixed top-up payment worth 50% of the value of their initial payment that does not involve reopening or reassessing of their claim;
 - deliver further increases in capacity for claims processing to at least 2,000 claims per year from 2026/27, increasing to 2,150 from 2027/28;
 - enable an independent review of redress decisions where survivors are unhappy with the outcome of their claim; and
 - establish a new Ministerial advisory group to provide an opportunity for input and engagement on the implementation of changes.
- 11 Redress payments are only available to living survivors or to the whānau of survivors who lodged a claim before their passing. This policy remains unchanged and was reaffirmed by Ministers.
- The Government's decisions respond to many of the redress recommendations in He Purapura Ora and Whanaketia. They are part of the overall Crown response to the 207 recommendations from the Royal Commission directed at the Crown which will be available on the Crown Response Office website.

Conclusion

The Government acknowledges survivors of abuse and neglect in care, and their supporters. It thanks them for their courage in speaking out and enabling

their abuse and neglect to be unearthed by the Royal Commission, documented and acknowledged.


