Supporting a community-led approach to the National Day of Reflection and next steps for the Survivor Support and Recognition Fund

Proposal

This paper seeks agreement to establish a contestable fund of \$1m to support the community-led approach to the one-off National Day of Reflection on abuse in care on 12 November 2025. It also seeks agreement to provide a further \$2m of funding to enable a second round of the Survivor Support and Recognition Fund due to the first round being oversubscribed.

Relation to government priorities

This paper progresses the Government's response to the Royal Commission of Inquiry into Historical Abuse in State Care and in the Care of Faith-based Institutions (the Royal Commission).

Background

- During the Crown's public apology for abuse in care on 12 November 2024, the Prime Minister announced a one-off 'National Remembrance Day' on 12 November 2025. The purpose of this day is to "call the country to reflect on abuse in care, survivors of abuse, and those who have passed away".
- The day will be called the 'National Day of Reflection' and will have the following intended outcomes:
 - 4.1 survivors of abuse in care are acknowledged and remembered;
 - 4.2 raise awareness about historic abuse in care and the story of care in New Zealand;
 - 4.3 raise awareness about contemporary care in New Zealand and the need to prevent abuse; and
 - 4.4 people are informed about the Government's progress on responding to the Royal Commission of Inquiry into Abuse in Care's recommendations.
- On 19 May 2025, the Crown Response Ministerial Group endorsed the outcomes for the National Day of Reflection and agreed that it would take a community-led approach. Accordingly, the day will consist primarily of a combination of community-led events and/or activities, along with activities organised by government agencies that demonstrate progress, accountability, and transparency. Other groups, including faith-based, non-government care organisations, and lwi, can choose to mark the day in their own way.

- In October 2024, as part of agreed further actions to accompany the Crown's public apology for abuse in care, Cabinet agreed [SOU-24-MIN-0129 refers] to establish a survivor-focused fund, the 'Survivor Support and Recognition Fund' (SSRF), which supports:
 - 6.1 local authorities in Auckland, Waikato, Nelson, Rangitikei, Horowhenua, Porirua, Otago, Westland and Canterbury, in their work already underway, or in proposed new projects, to care for or memorialise unmarked graves associated with psychiatric hospitals, psychopaedic sites, or other sites that were places of care; and
 - 6.2 initiatives delivered by non-governmental organisations (NGOs) providing direct support to survivors, including survivor-led initiatives.
- The intent of the SSRF was to achieve one of the shifts identified in the Royal Commission's final report, *Whanaketia Through pain and trauma, from darkness to light* to address the wrongs of the past through actions to acknowledge and memorialise victim and survivor experiences. This responds to recommendations from the Royal Commission to accompany acknowledgements and apologies with tangible demonstrations of reconciliation and to fund projects to investigate unmarked graves.
- Cabinet agreed [SOU-24-MIN-0129 refers] that the SSRF would initially be allocated \$2 million and authorised the Associate Finance Minister, Lead Coordination Minister and Minister for the Public Service to finalise the detailed design of the fund. Joint Ministers agreed in December 2024 that \$500,000 would be allocated to initiatives by local authorities on unmarked graves and \$1.5 million for initiatives to support NGOs to provide supports and services to survivors of abuse in care.
- The SSRF is non-contestable, whereby applications that meet the criteria can be funded up to \$50,000. The SSRF is administered by the Department of Internal Affairs (DIA), with the Crown Response Office providing operational policy oversight and engagement support. The SSRF was opened in February and the funding for initiatives providing direct support to survivors has now been fully distributed. Organisations who have received funding are included in Annex One.

Establishing a contestable fund will support the community-led approach to the National Day of Reflection

- To achieve the intended outcomes of the one-off National Day of Reflection, there will need to be events held across the country, by organisations that represent, support, or are otherwise connected, to, a wide range of survivor communities. Survivor engagement has highlighted their aspiration for both smaller, community-focused, organisations and larger groups, that represent and advocate for survivors at a regional and national level, to hold events on the day.
- The simplest mechanism to reach this range of groups is to establish a contestable 'National Day of Reflection Fund' (NDRF) to be operated by the same DIA team managing the SSRF. A contestable fund is recommended to

ensure a geographic spread of community events and involving a diverse range of communities, within a fixed level of funding. A new category within DIA's Multi-Category Appropriation will be established for the NRDF, as the scope of the existing category for the SSRF is limited to support services for survivors or work by local councils on unmarked graves.

- I propose \$1 million be allocated for the NDRF. This level of funding will support 100 to 150 community events across the country, which will enable national coverage and a wide range of communities organising events. DIA is able to absorb the administration of the fund into its baseline costs, which allows the full amount to be distributed to community organisations or local government. The funding level for the NDRF has been proposed based on research which estimated the number and type of organisations who may seek to run an event and reflects the relatively tight timeframes for organisations to prepare and submit proposals.
- The Crown Response Office will finalise the detailed design of the fund, including the funding caps for the different categories of activities, following that decision.
- I propose organisations operated by churches are excluded from applying for the NDRF due to the findings of the Royal Commission of faith-based institutions, alongside the state, historically failing to protect and safeguard children and vulnerable adults from abuse in care. It is therefore appropriate that they fund any event that they hold.

Next steps for the Survivor Support and Recognition Fund

- The SSRF opened for applications on 19 February 2025 and has been fully allocated. While it is too early for officials to conduct a full evaluation of the impact of the SSRF, uptake data shows there is significant demand for community-based supports and services for survivors of abuse in care.
- The \$1.5 million funding allocated through this fund has enabled NGOs to deliver services and supports across all regions of New Zealand, to a wide range of survivor cohorts. These services and supports include advocacy, wellbeing supports, workshops, and awareness initiatives. Further organisations have indicated their intention to apply for funding through the SSRF but are unable to progress these due to it being fully allocated.
- All nine relevant local authorities have either applied or stated a specific intention to apply for funding for work related to unmarked graves. Local authority applications are taking longer to develop than those for NGOs because of a longer lead-in time required for Councils to develop and approve their applications. This reflects the number and range of stakeholders, the uncertainty that remains about the extent and location of unmarked graves, and the nature and timing of Council-approval processes.
- I recommend we extend the SSRF to provide a second round of funding to continue to provide locally delivered support for survivors, with a primary focus on funding initiatives from new applicants. I propose an additional \$2 million in funding be provided to the SSRF, which would be met from the

tagged operating contingency which was established as part of Budget 25 to support the Government's implementation of the Royal Commission response [CAB-25-MIN-0126.72 refers]. I will announce the next round of funding for the SSRF on the National Day of Reflection.

Financial Implications

- The \$1 million funding for the NDRF will be met from the Crown Response Office's 2025/26 baseline. As a forecasted underspend in the departmental output expense appropriation 'Responding to the Abuse in Care Inquiry' for 2024/25 of approximately \$1.520 million relating to the Crown's public apology is available to transfer to 2025/26 and/or 2026/27 [CAB-25-0126.72 refers], meeting the cost of the NDRF from the Crown Response Office's baseline will not impact the Crown Response Office's ability to deliver its 2025/26 work programme. To enable grants to be made to successful applicants, \$1 million needs to be transferred from Vote Public Service to Vote Internal Affairs.
- I propose that the second round of funding of \$2m for the SSRF be drawn down from the tagged operating contingency *Implementing the Government's Response to the Royal Commission of Inquiry into Abuse in Care* established as part of Budget 2025 [CAB-25-MIN-0126.72 refers]. I also propose Cabinet agree that subsequent policy initiatives that support that Government's response to the Royal Commission and that require funding of \$3 million or less from this tagged contingency, can be approved by the Lead Coordination Minister, Minister of Finance and other relevant appropriation Minister/s in order to draw down funding from the contingency.

Legislative Implications

21 The proposals in this paper have no legislative implications.

Population Implications

Several population groups are over-represented, as both survivors of abuse in care and in the current care system. They include tamariki, rangatahi and pakeke Māori, Pacific Peoples, culturally and linguistically diverse communities, Deaf and disabled people (including whaikaha Māori, people who experience mental distress), Takatāpui, Rainbow and MVPFAFF people.

Human Rights

23 The proposals in this paper do not have human rights implications.

Use of external resources

No external resources have been used to prepare the advice in this paper.

Consultation

The Department of Internal Affairs and The Treasury have been consulted on the proposals in this paper.

Communications

Officials are preparing a communications plan to announce the NDRF, subject to Cabinet decisions. The Lead Coordination Minister will announce the additional funding for the SSRF on the National Day of Reflection.

Proactive Release

This paper will be proactively published on the Crown Response Office's website with appropriate withholdings under the Official Information Act 1982.

agreed to provide additional funding of \$2.000 million to enable a second round of the Survivor Support and Recognition Fund to take place in 2025/26;

- 13 agreed that the Crown Response Office will finalise the detailed design and criteria for the second round of the Survivor Support and Recognition Fund, with the first priority being organisations that did not receive funding in the first round due to the fund being oversubscribed,
- authorised the Lead Coordination Minister for the Government's Response to the Royal Commission's Report into Historical Abuse in State Care and in the Care of Faith-based Institutions (the Lead Minister) to make any appropriate changes to the parameters and/or eligibility criteria of the first round of the Fund;
- noted that Budget 2025 established a tagged operating contingency 'Implementing the Government's Response to the Royal Commission of Inquiry into Abuse in Care' (the tagged operating contingency) totalling \$28.375 million over four years [CAB-25-MIN-0126.72];
- noted that in June 2025, Cabinet agreed to reduce the tagged contingency by \$7.000 million to provide additional funding for redress payments to survivors of torture at the Lake Alice Child and Adolescent Unit [CAB-25-MIN-0190], meaning the total is now \$21.375 million over four years;
- agreed to a partial draw-down of \$2.000 million from the tagged operating contingency to provide for the additional funding requirement of the second round of the Survivor Support and Recognition Fund;
- approved the following changes to appropriation to provide additional funding to enable a second round of the Survivor Support and Recognition Fund to take place in 2025/26, with a corresponding impact on the operating balance and net core Crown debt:
