This Easy Read is a pānui / newsletter from the **Crown Response Office**.



The Crown Response Office is in charge of the Government response to the Royal Commission of Inquiry into Abuse and Neglect in Care.



It is sometimes called the CRO.







- children
- young people
- vulnerable adults.





Abuse and neglect can be things like someone:

- hitting you
- calling you names
- taking your money
- not letting you have the things you need like food.

A Ministerial Advisory Group:

- is made up of people who are not part of the Government
- gives advice to the Government.





The Survivor Experiences Board:

- is mostly made up of survivors
 from a lot of different
 backgrounds
- gives advice to the Survivor
 Experiences Service.



People who have been through abuse in care are called **survivors**.





The **Survivor Experiences Service** supports survivors to:

- talk about what heppened when they were in care
- get records / information about their time in care.

Alana Ruakere

Alana Ruakere will be the chair of the Ministerial Advisory Group.



The **chair** is the person who leads meetings of the Ministerial Advisory Group.



Alana is the **Pou Tū Kūrae** / **Chief Executive** of Tui Ora which is a health service provider for Māori.



A Pou Tū Kūrae / Chief Executive is the person in charge of an organisation.



Alana has also been the director of the **Crown Response Unit**.



The **Crown Response Unit** was a group of people who worked for the government to look after:



 contact between the Government and the Royal Commission



 the Government response to what the Royal Commission finds out.

The Crown Response Unit was called the **CRU** for short.



She was in charge of the first part of the Government response to abuse in care.

David Crichton



David Crichton is a survivor.

David told the Royal Commission of Inquiry about his experiences in care.



He was also part of the Redress
Advisory Group which worked with
the Government to decide how to do
redress for survivors.



Redress means someone:

- agrees that something bad has happened
- does something to try to put things right.

Valerie Tan



Valerie Tan is a psychologist.




A **psychologist** supports people to deal with:

- their feelings
- things that have happened in their lives.



Valerie knows a lot about:

trauma which is what happens
 when someone has been through
 something very bad





 equity which is treating people fairly.



Gary Williams

Gary Williams is a tangata whaikaha / Māori disabled survivor.



He is part of the Ngāti Porou iwi.

Gary was part of the Survivor Advisory Group of Experts.



The Survivor Advisory Group of Experts supported the Royal Commission of Inquiry to find the right way to work with survivors.



The Survivor Advisory Group of Experts is called **SAGE** for short.



Gary is also part of the Survivor Experiences Board.



Gary has been given the **Honours**:

- King's Service Order
- Member of the New Zealand
 Order of Merit.



Honours are awards the
Government gives to people who
have done good things for Aotearoa
New Zealand.



Paul Gibson

Paul Gibson was the first **Disability Rights Commissioner** in
Aotearoa New Zealand.




The **Disability Rights Commissioner** speaks up for the **rights** of disabled people.



Rights are things the law says everyone should:








Rights are things like:

Paul has worked with a lot of human rights groups.



Paul had been given the Honour Queen's Service Order.

Helen Leahy



Helen Leahy leads Ngā Waihua o Paerangi which works to support Māori in the Ruapehu area.



She has worked to make life better for Māori in things like:

- health
- education / schools
- justice / the law.



Frances Tagaloa



Frances Tagaloa is a survivor.



She was the first survivor to talk to the Royal Commission about abuse in the Catholic Church.





She is 1 of the chairs of the Survivor Experiences Board.



Frances has been a leader in the Christian groups:

- Campus Crusade for Christ
- Tandem Ministries.



She has been given the Honour King's Service Order.



Linda Surtees

Linda Surtees leads **Caring Families Aotearoa**.



Caring Families Aotearoa gives support to caregivers who are fostering children.



Fostering means taking care of children when their parents cannot look after them.



Linda knows a lot about:

- keeping children safe
- supporting children who are going through a hard time.



She has done a lot of work to speak up for children in foster care.



Linda has been given the Honour

Member of the New Zealand Order of

Merit.
